
Re: Cease and Decease of All Communications with Plodzick & Sanderson, P.A.

Dear Mr. Vitale:

This office represents Plodzick & Sanderson, P.A. (the "Firm"). You have directed several inquiries to the Firm concerning its services to the Town of Plaistow (the "Town") and to the Timberlane Regional School District (the "School"). As you have been told, by members of the Firm and by Town and School officials, the Firm will respond to questions and requests from those officials acting in the scope of their duties, but not to others. The Firm is not a public agency or public body subject to RSA 91-A. The Firm's contracts with the Town and School do not authorize the Firm to communicate to third parties about its audit and other accounting services.

Your continuing efforts to obtain information from the Firm and its staff interferes with their professional activities and constitutes harassment. Please cease all further contact with them. If you ignore this courtesy letter and persist, our client may have no alternative but to seek other relief, which may include obtaining injunctive relief from the appropriate court and recovery of its damages. We trust that action will not be necessary.
